

Leisure Access Program

The City of Surrey Leisure Access Program is designed to support Surrey residents who are in financial need. The application process supports the diversity of family structures within the community and addresses the eligibility based on the family net income, as defined by Canada Revenue Agency.

Leisure Access Pass provides the following benefits to its holders:

- One-year Full Facility Family Pass
- 75% discount on most registered programs inquire with the front desk staff to see which programs are eligible.

How to Apply

Complete this form and bring it to any Surrey Parks, Recreation and Culture centre along with all the required documents. A Leisure Access Pass will be granted if the family income is below the applicable family income threshold. A small non-refundable administration fee is required in order to process the application.

Income for families greater than seven will be based on \$45,580 plus \$6,500.
